The Discover Uni data collection is managed by the Office for Students on behalf of the four UK Higher Education funding and regulatory bodies, and delivered in partnership with the Higher Education Statistics Agency. It provides information on UK higher education courses to help prospective students choose their course. This information is currently published on the Discover Uni website.

Accreditation and Discover Uni

The Undergraduate Endorsement scheme is intended to endorse undergraduate degrees that provide the underpinning knowledge and skills required for a career in sport and/or exercise science – therefore a variety of degree courses will be eligible for endorsement, not just courses with the title "Sport and Exercise Science".

The completion of a CASES endorsed degree recognises that the student/graduate has fulfilled part of the knowledge/skill requirements required of applications for becoming a Sport and Exercise Accredited member with CASES.
